QUALIFICATIONS

Qualifications for Membership

- Class I & Class II memberships are subject to an initiation fee of \$4,000
Social memberships – Class III are subject to an initiation fee of \$500
- If a Social Member – Class III wishes to reclassify to a golfing membership (Class I or Class II), they must remit the difference between initiation fees.
 - Club membership is not transferable
 - Corporate memberships are prohibited
 - New members must remit prorated membership dues
- Membership dues are billed quarterly (January 1, April 1, July 1, October 1)

Rights of Membership

The rights of membership extend to the member, spouse and unmarried children under the age of 25 as long as they are full-time students, or age 22 if not a student.

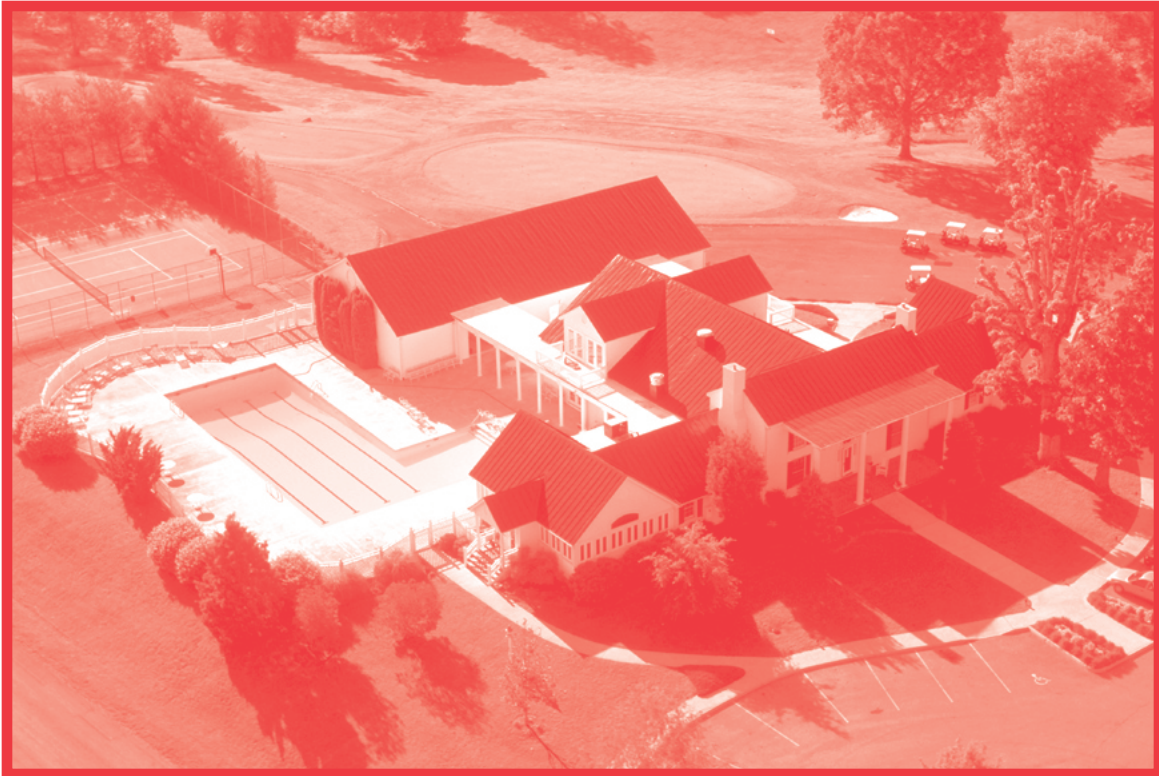
